Risks and hazards: The following are risks and hazards of the Aerial Adventure Park, Summer and Winter Mountain Adventure Park (including the Mountain Coaster, Soaring Eagle Zip Ride, Alpine Super Slide, Giant Swing, Rock Climbing Wall, Euro-Bungy trampoline, Bouncy House, Spider Web, Kid Climb, Berkshire Express Scenic Ride and other chairlifts, and Tubing), 13 Nights, Mountain Biking, hiking, skiing, snowboarding, and other physical activities or facilities (collectively, "**Activities**") at Jiminy Peak Mountain Resort ("**Resort**"), and I acknowledge that:

- The Activities at the Resort are inherently dangerous with risks of ***injury, severe illness, permanent disability, death and property damage*** (collectively, "**Loss**") including but not limited to:
 - falling, slipping, jolting, jarring or shaking
 - uneven and/or slippery ground or track conditions, high elevation
 - continually changing adverse weather conditions, natural elements
 - encounters with plants, insects or animals
 - breaks, sprains, strains, bruises and other contusions
 - collisions with other participants or man-made or natural objects, including the props or equipment used in the production of 13 Nights
 - variations in terrain; surface or subsurface snow or ice conditions or bare spots; ruts, bumps, banks
 - vehicles and machines including snowmobiles and snowcats
 - the use of lifts
 - my use of the equipment and my presence on the Resort
 - carelessness and misjudgments on the part of participants and Resort staff, including by failing to follow proper procedures, instructions and the operating policies of Resort
 - rocks, trees, stumps and other forms of forest growth or debris
 - equipment failure, malfunction, or improper use of equipment
 - various special effects, lighting, fog, intense sound, automation and trained performers specifically designed to scare me
 - my health condition, physical exertion, dehydration, fatigue, anxieties and fears associated with heights, dizziness
 - illness, including exposure to and infection with viruses or bacteria
 - other risks and dangers that can reasonably be inferred from the other risks and dangers listed here
- These risks and dangers are obvious and necessary to participate in the Activities. Participating in these Activities could increase the risk of contracting a virus or viral or bacteriological disease.
- There may be other risks not known or reasonably foreseeable at this time; and for safety purposes, the areas of the Activities may be under video and audio surveillance.
- Having a Resort employee present does not reduce the amount or severity of the risks or hazards of these Activities.
- If I violate any Resort rules, I may have my pass revoked without refund.
- ***I made a voluntary choice to participate in the Activities even though there are risks and dangers.***

Assumption, Release, Covenant: In consideration of the terms of this agreement and as an express condition of my participation in the Activities, I hereby agree:

- to assume all dangers and risks, inherent or otherwise, of **any Loss** resulting from my participation in the Activities at the Resort (and as may be provided by state statute); and refrain from reckless conduct that is not consistent with safe and prudent participation in the Activities, or violates the Resort's rules or the law;
- there exist extremely contagious viruses (including the COVID-19 coronavirus) that spread easily through person-to-person contact; that federal and state authorities recommend social distancing as a means to prevent the spread of these viruses; and that none of the Resort Parties warrant that viral or bacteriological infection will not occur through participation in the Activities at the Resort;
- not to bring a claim against and **agree to release and forever discharge** Jiminy Peak Mountain Resort, LLC, Belmont JP Ski, LLC, Centerplate, Wiegand Sports GmbH, their respective employees, officers, managers, parent companies, affiliates, mortgagees, agents, and their successors in interest (collectively "**Resort Parties**"), from all liability for **any Loss** that results from activities that are in any way related to my participation in the Activities, the use of the Resort Parties' equipment, **including all liability that results from the negligence of the Resort Parties, or any other person or cause; and all claims that I may now have against the Resort Parties, or claims of which I am not aware or are not mentioned in this release. This release also applies to claims resulting from anything which has happened up to now;**
- agree to **indemnify** the Resort Parties from any and all losses, liabilities and attorney's fees resulting from any claims or suits for **any Loss** that arises out of my participation in the Activities, use of the equipment, or any other activities on the Resort, regardless of how or by whom or by what the Loss was caused, or any subrogation or derivative claims brought by any third party or insurer for any Loss I may cause;
- that this agreement is legally binding on me, my heirs, executors, administrators and assigns; is governed by the laws of the Commonwealth of Massachusetts; and will be interpreted to provide as broad and inclusive a release of liability as is legally permissible, but it is not intended to assert any claims or defenses that are prohibited by law;
- to grant exclusive permission to the Resort Parties to use my image(s) for the purpose of publicity, public relations, editorial, or other advertising purposes without restriction as to frequency or duration
- that **exclusive jurisdiction and venue for any legal action against the Resort Parties is in Superior Court of Berkshire County, Massachusetts or the federal courts of the Western District of Massachusetts and those courts have personal jurisdiction;**
- that the Resort Parties are granting me permission to use the Resort, their facilities, and equipment in exchange for me signing this agreement; and
- that this agreement will survive and continue in force beyond the end of the current Activities season with respect to any Loss occurring before that time.
